Re: FY-2018 F1 Scheduler Clerk Bid Times Changes

Don:

After discussing the new 'FY-2018 F1 Scheduler Clerk Bid Times Changes' on the 2-page attached letter with the APWU at the National level, the payment of out-of-schedule premium is not really the proper way to compensate the employees that are having to continue working their schedules they have now, versus the new schedules you are changing them to effective Saturday, October 28, 2017. The APWU would need a PS Form 1723 for the management initiated change of schedule for each of the 59 employees that you are changing schedules from the 'new' reporting time, as stated in the October 19, 2017 letter, to the hours they are presently working since the last change approximately 6 weeks ago.

There is a National Level Step 4 agreement which states in part that, "management may not schedule employees for the purpose of intentionally circumventing the overtime desired list provisions." The OTDL (overtime desired list) are the employees that should be working the hours outside of the new reporting time changes effective October 28, 2017.

An example of this would be:

- If employee A had his/her hours changed to 1500 hours previously, and now you are changing them to 1650, but saying that you will continue working them at the 1500 hours and paying them out-of-schedule pay from 1500-1650, then the additional ½ hour of pay in addition to the regular rate of pay he/she works is quite a bit different than the overtime rate of pay from 1500-1650.
- The OTDL should be the deciding factor as to which employees are brought in at those times (according to the OTDL rotation). By paying out-of-schedule pay for the 1½ hour (in the example above) there is a chance that the employee(s) are losing out on overtime, Penalty Pay, and the OTDL Clerks could also be losing out on the overtime from 1500-1650.

I am unsure what the reasoning is to simply change their schedules on paper and keep everything the same? Is it just to look like the Function 1 Scheduler is being followed since it may appear as such on paper, but in reality, this management decision is a contractual violation, and has the potential to cause many OTDL employees a loss of their contractual opportunities to work the overtime. This needs to be discussed as expeditiously as possible. Thank you in advance.

Dear Mr. Days:

on May 27, 1993, we met to discuss the above-captioned grievances at the fourth step of our contractual grievance procedure.

The issue in these grievances is whether management violated the National Agreement in its overtime scheduling on July 14, 1992.

After reviewing this matter, we mutually agreed that no national interpretive issue is fairly presented in these cases. We further agreed that, while the overtime desired list provisions were not violated in this instance, management may not schedule employees for the purpose of intentionally circumventing overtime desired list provisions. The question of whether management did so in this instance is a non-interpretive factual question: The issue of simultaneous scheduling was addressed by arbitrator Mittenthal in case H4C-NA-C 30.

Accordingly, we agreed to remaind these cases to the parties at Step 3 for further processing in accordance with the above understanding.

Please sign and return the enclosed copy of this decision as your acknowledgment of agreement to remand these cases.

Time limits at Step 4 were extended by mutual consent.
